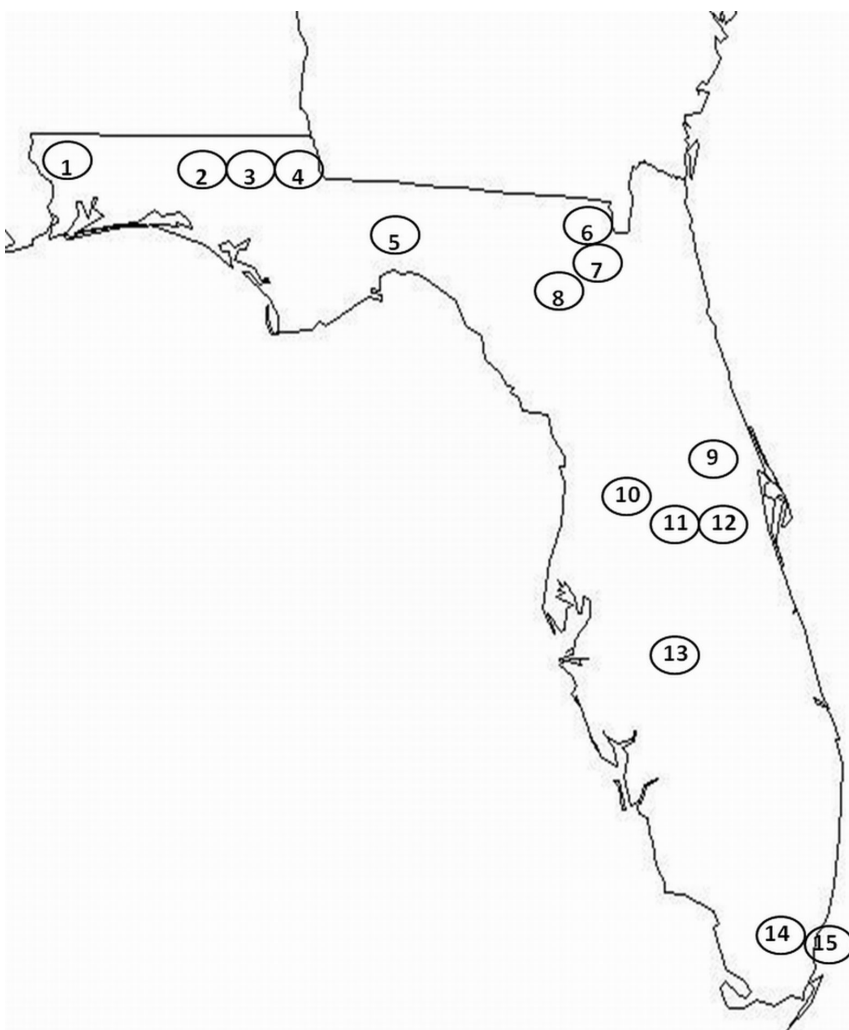


## USDA Inspected Livestock Slaughter Facilities in Florida<sup>1</sup>
